### Revision in Expiry Day of Index and Stock Derivatives Contracts - Update

This is in reference and partial modification to Exchange circular reference 68685 dated June 23, 2025 on Revision in Expiry Day of Index and Stock derivatives contracts where Exchange had informed the following revision in expiry day of the Index and stock derivatives contracts:

Accordingly, members are requested to note the following w.r.t expiry day of existing contracts and newly generated contracts as under:

1. The expiry of already introduced i.e. existing index and stock derivatives contracts with expiry falling on / before August 31, 2025, will remain unchanged except for long dated option contracts in NIFTY & BANKNIFTY (i.e. September 2025 expiry and onwards).
2. Expiry day of existing long dated option contracts in NIFTY & BANKNIFTY (i.e. September 2025 expiry and onwards) shall be modified to re-align with revised expiry day (i.e. Tuesday) on **July 31, 2025 EOD** and shall be available in the contract master file generated on July 31, 2025 EOD.

3. Newly generated contracts with expiry falling on/after September 01, 2025 shall be introduced with revised expiry day (i.e. Tuesday) effective from **June 26, 2025 EOD onwards** and shall be available in the respective day's contract master file.
4. An illustration is provided **as Annexure** below for ease of understanding.
5. Members are requested to note that there is no other change in the contract specifications of index and stock derivatives.
6. The settlement schedule shall be intimated separately by Clearing Corporations.
7. Members are advised to take the updated contract.gz, spd\_contract.gz, MII - Contract.gz and MII - spd contract.gz file available on extranet path faoftp/faocommon before trading.
